We are calling on the 118th Congress to reintroduce these important measures and send them to the President's desk to be enacted.





A | HONOR THE GOD-GIVEN WORTH AND DIGNITY OF ALL PEOPLE

LIFE AT CONCEPTION ACT (H.R. 1011 / S. 99)

Legally recognizes that life and personhood begins at conception, and that the full rights of the unborn are protected by the Fourteenth Amendment to the United States Constitution.

HEARTBEAT PROTECTION ACT (H.R. 705)

Requires physicians to check for a fetal heartbeat before performing an abortion and restricts abortions where heartbeats can be detected (generally beginning at six weeks).

PROTECTING PAIN-CAPABLE UNBORN CHILDREN FROM LATE-TERM ABORTIONS ACT (H.R. 8814 / S. 4840)

Establishes a limit on abortions at or beyond fifteen weeks gestational age, when medical evidence demonstrates that unborn children are capable of experiencing pain.

DEFUND PLANNED PARENTHOOD ACT (H.R. 541 / S. 139)

Ends all taxpayer funding for Planned Parenthood, the largest provider of abortion in America.

CHILD WELFARE PROVIDER INCLUSION ACT (H.R. 1750 / S. 656)

Ensures that there are no barriers to the full participation of faith-based adoption, foster care, and pregnancy resource centers in the vital care of children and their families.

TELEABORTION PREVENTION ACT (H.R. 5136)

Curbs the dangerous efforts to circumvent life-saving protections through mail-order abortion pills.

BORN-ALIVE ABORTION SURVIVORS PROTECTION ACT (H.R. 619 / S. 123)

Clarifies that any child born-alive after a failed abortion attempt must be given immediate access to life-saving care.

NO TAXPAYER FUNDING FOR ABORTION & ABORTION INSURANCE FULL DISCLOSURE ACT (H.R. 18 / S. 92)

Ends federal taxpayer-funding for abortion once and for all.

PROTECTING LIFE AND INTEGRITY IN RESEARCH ACT (H.R. 563 / S. 77)

Ends all federal funding for destructive fetal tissue research, instead supporting non-destructive research using adult stem cells and other ethical sources.

PROTECTING LIFE IN FOREIGN ASSISTANCE ACT (H.R. 534 / S. 137)

Permanently bans foreign aid funding for abortions.

PREGNANT STUDENTS' RIGHTS ACT (H.R. 7294 / S. 4277)

Ensures that pregnant students know their rights and are not pressured into an abortion on campus.

PROTECTING LIFE ON COLLEGE CAMPUS ACT (H.R. 4607 / S. 2408)

Prohibits federal funds from flowing to universities that provide unsafe chemical abortion pills to students.

B | CELEBRATE RELIGIOUS FREEDOM

FREE SPEECH FAIRNESS ACT (H.R. 837)

Allows religious leaders to publicly talk about politics and policy without retribution from the IRS by repealing the Johnson Amendment's censorship of 501(c)3 employees.
