# THE FUTURE OF FREEDOM

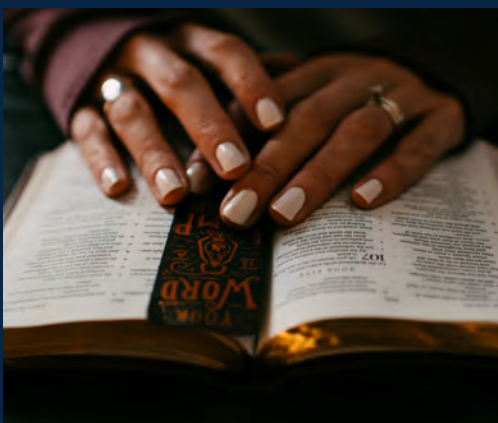
“For all the time that we have and all of my days that remain on this Earth, I will always stand for life, and I’ll always stand with each and every one of you. That’s my solemn promise.

## SUPPORT:

### **LIFE AT CONCEPTION ACT (H.R. 431)**

Legally recognizes that life and personhood begins at conception, and that the full rights of the unborn are protected by the Fourteenth Amendment to the United States Constitution.

### **HEARTBEAT PROTECTION ACT (H.R. 175)**

Requires physicians to check for a fetal heartbeat before performing an abortion and restricts abortions where heartbeats can be detected (generally beginning at six weeks).

### **PROTECTING PAIN-CAPABLE UNBORN CHILDREN FROM LATE-TERM ABORTIONS ACT**

Establishes a limit on abortions at or beyond fifteen weeks gestational age, when medical evidence demonstrates that unborn children are capable of experiencing pain.

### **DEFUND PLANNED PARENTHOOD ACT (H.R. 371)**

Ends all taxpayer funding for Planned Parenthood, the largest provider of abortion in America.

### **CHILD WELFARE PROVIDER INCLUSION ACT (H.R. 6485 / S. 3344)**

Ensures that there are no barriers to the full participation of faith-based adoption, foster care, and pregnancy resource centers in the vital care of children and their families.

### **TELEABORTION PREVENTION ACT (H.R. 421)**

Curbs the dangerous efforts to circumvent life-saving protections through mail-order abortion pills.

### **BORN-ALIVE ABORTION SURVIVORS PROTECTION ACT (H.R. 26 / S. 204)**

Clarifies that any child born-alive after a failed abortion attempt must be given immediate access to life-saving care.

### **NO TAXPAYER FUNDING FOR ABORTION ACT (H.R. 7 / S. 62)**

Ends federal taxpayer-funding for abortion once and for all.

## **PROTECTING LIFE AND INTEGRITY IN RESEARCH ACT (H.R. 398)**

Ends all federal funding for destructive fetal tissue research, instead supporting non-destructive research using adult stem cells and other ethical sources.

## **PROTECTING LIFE IN FOREIGN ASSISTANCE ACT (H.R. 2492)**

Permanently bans foreign aid funding for abortions.

## **PREGNANT STUDENT'S RIGHTS ACT (H.R. 6914 / S. 2974)**

Ensures that pregnant students know their rights and are not pressured into an abortion on campus.

*Sponsored by Rep. Ashley Hinson and Sen. Marco Rubio*

## **PROTECTING LIFE ON COLLEGE CAMPUS ACT (H.R. 435 / S. 16)**

Prohibits federal funds from flowing to universities that provide unsafe chemical abortion pills to students.

*Sponsored by Rep. Chip Roy and Sen. Steve Daines*

## **FACE ACT REPEAL ACT OF 2023 (H.R. 5577 / S. 3017)**

Repeals the unconstitutional FACE Act which infringes on state police powers by federalizing crimes that occurs near or in an abortion clinic.

## **SAVE MOMS AND BABIES ACT OF 2023 (H.R. 427 / S.92)**

Prohibits the approval of new abortion drugs, studies on abortion drugs, and reimposes restrictions on mifepristone.

## **WOMEN'S PUBLIC HEALTH AND SAFETY ACT (H.R. 1074 / S.471 )**

Grants states more flexibility to exclude abortion providers from state Medicaid programs.

## **TITLE X ABORTION PROVIDER PROHIBITION ACT (H.R. 330 / S.624)**

Prohibits abortion providers from receiving Title X grants.
